\$10.00 or 3.00% of the amount of each cash advance, whichever is greater, however, the fee will never exceed \$35.00.

Returned Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less.

Returned Convenience Check Fee:

\$25.00 or the amount of the returned convenience check, whichever is less.
